JOINING INFORMATION

To assist you with your application, the following information has been provided by the Board to current members for the club's membership year commencing 1st May 2024.

Payment of Your Membership Fees:

The Board wish to clarify that all members are bound by the Club's Byelaws and Regulations which state that all fees are payable on **1st May** and that there is no '**grace period**' to continue using the facilities of the club from this date.

Payments are requested to be made promptly and in full by one of the following payment options:

- **Option 1 - ClubV1 app**, this is preferred as your membership record will be automatically updated.
- **Option 2 - Bank Transfer** - To the club's bank account as noted on the renewal notice, or
- **Option 3 - Debit/Credit Card** - With the office either in person or over the phone, or

Bar Levy – A £50.00 levy on each member [aged 18 and over] to be used on food and beverage. As per the Byelaws and Regulations 'unused bar levy, except for top-ups, will be forfeit at the end of the subscription year'.

30 & 50 Years Commemorative Pin – Qualifying members will receive a one-off top up to their member card as follows - 30 years continuous membership will receive £30.00 and 50 years continuous membership will receive £100.00. As before it remains that members attaining the age of 80 with 30 years continuous membership will receive Honorary membership in their current category.

Insurance [Golfing Members]:

As at previous renewals we have to remind you that golf is a dangerous sport, and you should be insured to cover your liability for 3rd party property damage, personal injury, and loss of equipment. England Golf currently provide Personal Liability Insurance (only) to members with an indemnity of up to £10 million. Please see the England Golf website for further details <https://www.Englandgolf.org/member-personal-liability-insurance/> Should you need to make a claim you will require your lifetime CDH ID number; if you do not have a CDH ID the club will issue all golf members with one during the renewal process.

The insurance should also include cover for your annual subscription in case you are unable to play due to injury at/away from the club and/or medical reasons. There is further information at the above link. As previously notified the Board will not consider requests to suspend membership.

There are various insurers who can provide annual insurance for you which are advertised in the golfing press or online.

Associate Membership Scheme (Flexible)

This category is only available to members already using the scheme.

Associate Member's account will be issued with £555.00 of credit to be used by 30th April 2025; this will be held in a separate purse.

- Prior to playing the course (either casually, competitively or representing the club in friendly matches) associate members will be required to present their membership card to the professional shop or bar where the appropriate fee will be deducted – weekday at £33.60; weekends and Bank Holidays at £46.25. Guest green fees may not be charged to the account.
- If you need to 'top up' your account this may be done at any time during the membership year. The minimum amount is £100.00 and is valid until 30th April 2025.
- Any unused credit will be forfeited at the 30th April 2025.
- Associate Members may enter all eligible club competitions **except** they are unable to win honours board competitions and to represent the club in official matches, but may play in club friendly matches.
- If it is found that an associate member has played the course without paying the appropriate fee prior to their round, membership of the club will be suspended with immediate effect and subject to the club's disciplinary procedures.

Overseas and Country Membership:

For the 2024/25 subscription year there will continue to be one category to cover all members living **over 40 miles** from the club. The membership will continue to follow the **associate category** model as detailed above but with the following criteria:

- **UK Residents** - Members must be domiciled at least 40 miles away from SHGC and provide a photographic ID and confirmation of address [driving licence].
- **Overseas Residents** – Members will be required to provide confirmation that they are resident and/or working abroad for a minimum period of 6 months of the subscription year.
- Membership is available to male and female applicants.
- Members may enter all eligible club competitions except are unable to win an honours board competition.

We hope that you will continue to take advantage of the club and its facilities when you are in the area to do so.

Temporary Categories [Waiting List]:

- To ensure the flow of members in to the club there will be 'Temporary Categories' available as the Board deem necessary. These categories may be restricted in nature and are only available to those on the waiting list for the Full [unrestricted] 7 Day category.
- As soon as a Full [unrestricted] 7 Day place becomes available and notified to the member the balance of the subscription is due in full, if applicable. The place may not be declined or deferred.
- A temporary category may only continue through a renewal by virtue of no places being available on the Full [unrestricted] 7 Day Category.

Golf Affiliation Fees – As per previous years these have been noted separately for 'golfing' members of the club and these fees will be paid over to the County and National Golf Unions/Bodies following receipt.

County Card – As a reminder the 'igCounty' App can be downloaded from the google store. This App is available for both men and ladies and you will need your CDH number to register.

Member Benefits – this year the following initiatives will be included with your membership

- Golfing membership includes social membership for a spouse or partner residing at the same address, please see fee structure below.
- Member Card Discount on bar sales with additional Food & Beverage promotions during the year, and beneficial rates on group bookings for a clubhouse event.
- Promotional offers for weekday guest green fees – details to follow.
- Reciprocal green fee arrangement with Chestfield GC, conditions apply.
- Loyalty cards for green fees, buggy hire, coffee & dish of the day purchases, conditions apply.
