Your application will be dealt with in a timely manner and a club Director will contact you to discuss your application and invite you to a meeting. Subject to a successful meeting your application will be confirmed by the office.

Golf Affiliation Fees – These fees are collected on behalf of England Golf and Kent Golf for all ‘golfing’ members of the club.

County Card - a new mobile app has been made available by Intelligent Golf and ‘igCounty’ App can be downloaded from the google store. This App is available for both men and ladies and you will need your CDH number to register.

Insurance:

Golf is a dangerous sport and you should be insured to cover your liability for 3rd party property damage, personal injury and loss of equipment. England Golf currently provide Personal Liability Insurance (only) to members with an indemnity of up to £10 million. Please see the England Golf website for further details <https://www.englandgolf.org/>

The insurance should also include cover for your annual subscription in case you are unable to play due to injury at/away from the club and/or medical reasons. The Board will not consider requests to suspend/refund your membership.

There are various insurers who can provide annual insurance for you which are advertised in the golfing press or online.

Overseas and Country Membership:

For the 2021/22 subscription year there will be one category to cover all members living over 50 miles from the club. The membership will now follow the associate category model as detailed on the next pages.

The qualifying criteria has changed for existing members of the club and are as follows:

1. **UK Residents** - members must be domiciled at least 50 miles away from SHGC and provide a photographic ID and confirmation of address [driving license].
2. **Overseas Residents** – members will be required to provide confirmation that they are resident and/or working abroad for a minimum period of 6 months of the subscription year.
3. Membership is available to male and female applicants.
4. Members may enter all eligible club competitions except are unable to win an honours board competition.

We hope that you will continue to take advantage of the club and its facilities when you are in the area to do so.

Restricted 7 Day (Temporary Category)

The Restricted 7 Day membership is only available to new applicants to the club where the 7 Day Category of membership is not currently available.

As soon as a 7 Day place becomes available and notified to the member the balance of the subscription is due in full, if applicable. The place may not be declined or deferred.

The Restricted 7 Day category is a temporary category and may only continue through a renewal by virtue of no places being available on the 7 Day unrestricted Category.

Access to the course is not restricted on a weekday but play is restricted at the weekends to after 2pm (BST) and after 12pm (GMT).

Associate Membership Scheme (Flexible)

The Board have decided currently to continue with the Associate Membership Scheme for those already using the scheme [no new applications].

1. Associate Member's account will be issued with £682.00 of credit to be used by 30th April 2022; this will be held separately to the current bar/competition top up.
2. Prior to playing the course (either casually, competitively or representing the club in friendly matches) associate members will be required to present their membership card to the professional shop or bar where the appropriate fee will be deducted – weekday at £26.50; weekends and Bank Holidays at £37.25. Guest green fees may not be charged to the account.
3. If you need to 'top up' your account this may be done at any time during the membership year. This amount will be credited to your account and is valid until 30th April 2022.
4. Any unused credit will be forfeited at the 30th April 2022.
5. Associate Members may enter all eligible club competitions **except** are unable to win honours board competitions and to represent the club in official matches, but may play in club friendly matches.
6. If it is found that an associate member has played the course without paying the appropriate fee prior to their round, membership of the club will be suspended with immediate effect and subject to the club's disciplinary procedures.
